Florida Institute of Technology (FIT) will offer 13 guaranteed minimum scholarships valued at half tuition per academic year (a value of around \$96,000 over four years) for use at FIT. Awardee must be admitted and attend FIT as a fulltime, degree seeking student to use these scholarships. Winners will be selected by judges from FIT. Students must meet the admissions criteria for the major they are enrolling in. Students are eligible to receive only one FIT Science & Engineering Fair Scholarship at the regional, state, or Intel ISEF levels of competition. If a winner, upon admission to FIT is eligible to receive an academic scholarship that is higher than half tuition per year, the higher scholarship will replace this scholarship.
